* Spruce Residential Radon Measurement Course Approvals

Accepted by most states and Canada. States include (but are not limited to):

California - Registered for 16 Continuing Education Hours by State of California, Bureau for Private Postsecondary and Vocational Education

Colorado - Colorado Department of Higher Education - 16 CEUs

Connecticut - State of Connecticut, Department of Consumer Protection - 16 hours CE

Florida - The state of Florida has specific licensing requirements for professionals performing radon measurement in homes. (HomeStudy course not approved for Florida exam.)

Illinois - The state of Illinois has specific licensing requirements for anyone performing radon measurement in homes. Also approved by Illinois Emergency Management Agency (IEMA) for one-time Category I Continuing Education. NOT approved for CE credit by the Illinois Department of Financial and Professional Regulation. (Home Study course not IEMA-approved.)

Indiana - The state of Indiana requires a person to be certified through NRSB or NEHA. This course is recognized by both.

Iowa - Approved by State of Iowa Department of Public Health

Maine - Approved by State of Maine Department of Human Services

Massachusetts - Commonwealth of Massachusetts - 2 hours CE (home inspection)

New York - The state of New York requires a person to be certified through NRSB or NEHA. This course is recognized by both.

North Carolina Home Inspector Licensure Board - 16 hours

Ohio - Approved by Ohio Department of Health

Pennsylvania - Approved by Commonwealth of Pennsylvania

Rhode Island - Approved by State of Rhode Island and Providence Plantations Department of Health

Tennessee - Approved by the Tennessee Higher Education Commission - 16 hours

West Virginia - Approved by State of West Virginia Bureau for Public Health
